

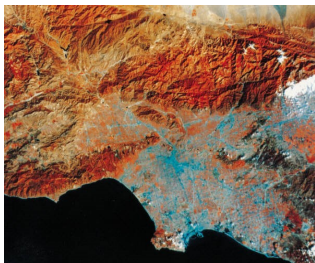
Become a CALAFCO Associate Member

CALAFCO Associate Membership

CALAFCO was created in 1971 as a statewide non-profit organization providing educational, technical, and specialized services to its members. Members include the staff and elected officials from all 58 Local Agency Formation Commissions.

Conferences, workshops, newsletters and electronic updates are among the benefits members enjoy throughout the year.

If you are interested in issues of urban growth and sprawl, local governance, agricultural and open space preservation, and effective municipal services — CALAFCO is a resource.

Changes in state law not only altered the role and responsibilities of LAFCoS, but mandated that new studies, such as municipal service reviews, be conducted. With limited staff, LAFCoS often rely on consultants to draft many of these fiscal and policy studies. Associate members are an important source for LAFCoS and community groups to turn to for assistance with studies and services.
